# Town's top student chef takes the cake

The annual Future Chef Competition Cook-off took place on March 20 at East Hartford High School, marking the 15th year of this exciting event and Josie Tedesco won the competition with her Yummy Yogurt

This year, students in grades 3 through 5 from East Hartford's eight elementary schools were invited to submit their favorite fruit or vegetable side dish recipes.

Out of the 40-50 applications received, five talented finalists were selected. However, due to unforeseen illnesses, three finalists competed in the cook-off. The competitors included Elizabeth Saucier, a fifth grader from Goodwin School, who prepared Celery Butterflies; James Kearns, a third grader from Goodwin School, who presented James' Kindness Fruit Kebab; and Josie Tedesco, a fifth grader from O'Connell School, who won the competition with her Yummy Yogurt Bowl.

Contestants worked alongside East Hartford High School culinary students and kitchen staff to ensure safe food preparation and professional guid-

# Dead dogs prompt Army to offer \$5,000 rewards

Less than a week apart, the discovery of two dead dogs improperly disposed of has shocked the town.

According to police, March 18 a golden retriever was found dead in a green garbage can behind the abandoned Stop & Shop on Silver Lane, plastic bags covering its head. And on Sunday morning a man poking around in the bushes by the Hockanum River waterfall off Cottage Street found a dead pitbull puppy in a garbage bag. Police said the dog had a puncture wound in its side which may or may not be a bullet hole.

Necropsies of both dogs are being performed, but the results will not be known for weeks.

East Hartford Animal Control officers said the dogs were thrown away as if they were trash. Police said they do not

believe the incidents are related, but they are investigating.

Officer Marc Caruso, Public Information Officer for the East Hartford Police Dept. and a dog handler of the department's new comfort dog, Beacon, told a local television station the discoveries are very upsetting, especially to anyone who cares for

"Anytime something like this happens we all know our animals are parts of our family. They are innocent and defenseless animals. So when you see this type of pain or behavior inflicted on an animal, it's sad for everyone involved, especially pet owners," he said.

Zilla Cannamela, president of Desmond's Army Animal Law Advocates told the Gazette that they have offered \$5,000 rewards for information leading to an arrest or prosecution of the people responsible, an offer which expires in 90 days.

Cannamela said if an animal passes away there are proper steps to take, including a burial in your backyard. Some towns offer a low-cost cremation of a pet, but East Hartford may not be one of those, she said. Call East Hartford Animal Control at 860-291-7572 to ask if they can help rather than disposing of an animal in the trash.

# Fear of felons with firearms

Concerned that the federal Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) is no longer responsible for vetting convicted felons who want to buy firearms, U.S. Sen. Richard Blumenthal convened a press conference at the East Hartford Public Safety Complex Monday to warn of dire consequences due to the takeover by the Justice Department (DOJ) of the permitting process.

Blumenthal, who has advocated for strengthening gun laws, noted an "interim final ruling" by U.S. Attorney General Pam Bondi would potentially restore the right to bear arms to 24 million felons.

Bondi cited a decades-old law that left the ATF "unable to effectuate its regulatory authority to act on individual applications due to an identical appropriations rider enacted annually," according to the ruling. Formerly, the ATF used to consider a felon's request for the return of their guns on a case-by-case basis. Now, according to Blumenthal, the DOJ will use an algorithm to make the decision.

Flanked by Mayor Connor Martin and Chief of Police Mack Hawkins, the senator decried the plan of the DOJ, under President Donald J. Trump, to restore gun rights of convicted felons - a class which includes the President himself.

# Making sure residents of mobile home communities are protected

Concerns by residents of Rivermead Pointe Manufactured Homes Community in East Hartford were brought before the General Law Committee this past week in Hartford.

After an explosive fire ripped through four mobile homes on the property last September, the number one priority has been safety.

First responders needed to connect to outside water sources to put out the fire because the water flow from the fire hydrants on the property was insufficient.

In testimony to the General Law committee, State Rep. Genga said, "What resulted was the need to close an entire road to run an adequate water line to extinguish the fire, delaying the much-needed assistance to the owners who were watching their closest personal possessions burst into flames.

"The residents of Rivermead Pointe are proof that leaving the public's safety in the hands of private out-of-state mobile park owners is insufficient at best and devastatingly consequential at worst.

Fire hydrants on the Rivermead mobile homes property are privately owned and inspected, noted Genga. "Owners

of the park were aware as early as 2019 that were problems with their fire hydrants when another fire broke out," Rep. Genga told the committee.

Rep. Genga's proposed legislation, HB 5428 "An Act Concerning Mobile Manufactured Home Parks," would require manufactured home communities like Rivermead Pointe to test their fire hydrants annually and report the results to the state Department of Consumer Protection.

If the data reveals insufficient water capacity and flow, the owner will be required to send quarterly reports to the department about the progress they are making to have the hy-

drants deemed safe and sufficient.


Rep. Genga urged the committee to pass the legislation "because public safety is our government's primary responsibility."

"I want to thank the several residents who testified on this issue to the committee, especially Heather Toutain and Rebecca Connors, who serve as co-chair of the resident's council," Rep. Genga said. "Their voices were heard by my colleagues on the committee."

The General Law committee approved the provision and sent the bill to the House for consideration.

## North End Senior Center has new purpose



The former North End Senior Center has been remodeled, becoming a local school conference center. The District will be placing a health clinic at the site as well, that remodeling work is just beginning.

The East Hartford Public Schools Conference Center on the Norris Campus was officially opened this past week with a small gathering of district leaders.

The facility located in what used to be known as the North End Senior Center has been undergoing a "face lift," according to school Facilities Director James Rovezzi. He noted that, over the past month, the District has spent around \$50,000 to bring the 1949 building into the 21st century. Gone is the old Bingo board as ceilings, floors, walls and windows were replaced while also bringing in modern technology to the building, new tables and chairs and bright graphics to the formerly blank interior walls.

Eventually "we will be running fiber optics as well," noted Rovezzi. The main conference room has a compacity of between 60 to 70 adults, and will be used by the school district for professional development education as well as a place for the school's District Leadership Team to meet.

Superintendent of Schools

Thomas Anderson noted that the district had been holding its monthly District Leadership Team meetings in various town schools, which tend to disrupt school's educational spaces. The team considered renting space at Goodwin University, but the vacant town building became available.

The town gave the district a five-year lease on the old senior center. The other half of the structure will be converted into a school-based health center to serve nearby Norris elementary school students.

"That will be the harder job," Rovezzi noted. Not only will it be necessary to replacing the outdated grid ceiling, walls, and windows the facility will need to be brought up to medical facility standards.

Anderson noted that the school district intends to hold only public school activities in the facility with usage limited and very strictly enforced.

Historically, the North End Senior Center was once a community center designed to serve residents of the nearby barracks-style housing development where McAuliffe Park now exists. A large wooden



Coach Lindsay Gottlieb said it. Everyone on the team picked it up, especially Iriafen. But the dream Bueckers-Watkins matchup is not to be this March, certainly to the disappointment of ESPN, her many NIL sponsors, and all fans of the women's game from Storrs to Long Beach. We only wish JuJu well, and know she's just a sophomore.

But that's something that can never be taken away and my name will always be there. I'm sure that there will be other guys down the road that will beat those records, although I don't think anyone will be breaking that ProStock record! 

# Blumenthal alarmed at change in gun rules

or not to return the gun rights to a felon or someone accused of a crime of domestic violence and assess who is going to be a threat will be decided by an algorithm," said Blumenthal. 'There are 24 million dangerous persons, who are convicted, off the street, of violent, dangerous crimes, crimes of violence, domestic abuse - now all of them will potentially have their guns back. This step is deeply disturbing and dangerous. It threatens public safety, domestic violence victims, and retailers who will be held up."

Blumenthal cited a 1992 spending bill restricting ATF from restoring the gun rights of felons was sidestepped by shifting the permitting process to the DOJ, the veteran senator called it a dangerous step, contrary to the spirit and letter of the law."

Locally, those applying for a gun permit will still need to be vetted by the police department, and no one with a felony conviction qualifies, said Chief of Police Hawkins. Asked if the East Hartford police would give President Donald J. Trump, who was convicted of a felony, a gun permit, the chief said he would wait until that moment

comes. "We will do what the law tells us to do. Our job must be to remain neutral. We will folthe law," said Chief low Hawkins.

Would a Presidential pardon restore the rights of those convicted for their actions on January 6, 2021 to own a firearm? Blumenthal said yes. "They will get their guns back."

The interim rule, posted in the Federal Register Thursday, follows a February executive order from President Trump directing a review of the country's gun restrictions to "assess any ongoing infringements."

Second Amendment advocates were concerned by denial of actor Mel Gibson's request to get his guns back which were taken away after he was convicted of a misdemeanor domestic violence in 2011. U.S. pardon attorney Elizabeth G. Oyer opposed restoring Gibson's gun rights, and was fired Friday as a result, she contends. The Bureau of Alcohol Tobacco, and Firearms (ATF) has the power to restore gun rights, but the agency has been blocked from doing so under congressional appropriations riders since 1992, the same restrictions that will now go away. Blumenthal noted.

Under Pam Bondi and the DOJ, the attorney general will now designate that power. The DOJ said the rule "reflects an appropriate avenue to restore firearm rights to certain individuals who no longer warrant such disability based on a combination of the nature of their past criminal activity and their subsequent and current lawabiding behavior."

The notice also said that "no constitutional right is limitless' and that they would be "screening out others for whom full restoration of firearm rights would not be appropriate."

We should be assessing on an individualized basis whether a person will be dangerous with
